- **FDA** released a [revised final guidance](#) regarding the Sep. 30 compliance deadline for the regulation of some tobacco products as initially outlined in the FDA final deeming rule.
- **CDC** published a new plain-language informational [webpage](#) on e-cigarettes to educate the public on its prevalence and health impacts.
- **NACCHO** published a series of local success stories overviewing how three local health departments—[Public Health Solutions \(NE\)](#), [Sioux Falls, SD](#), and [Utah County, UT](#)—leveraged [CDC Tips@](#) campaign resources to deliver tobacco-free messaging to different communities.
- **Campaign for Tobacco-Free Kids** added new tax-related [factsheets](#) to their U.S. state and local taxes resource page.
- The [Cancer Progress Report](#) released by the **American Association for Cancer Research** notes that significant reductions in adult cigarette smoking are largely responsible for the 38.7 percent reduction in lung cancer observed between 2000 and 2015.
- The **National Association of State Mental Health Program Directors** released a new [policy statement](#) in support of tobacco cessation treatment in all behavioral health settings.
- The Washington University **Center for Public Health Systems Science** updated its online [Program Sustainability Assessment Tool](#), which can be used to evaluate tobacco control interventions.

State News

- Clearway Minnesota published three community engagement [case studies](#) that describe how local stakeholders have connected diverse low socioeconomic status smokers in **Minnesota** to tobacco cessation services.
- A [bill](#) restricting the use of tobacco and marijuana products on beaches and state parks in **California** has been sent to the desk of Gov. Jerry Brown after approval by both branches of the state legislature.

In the News

- Over 100 international health organizations wrote a [letter](#) to Philip Morris International CEO Andre Calantzopoulos encouraging immediate cease of production and sale of cigarettes worldwide.
- A [study](#) published in *Cancer Cell* [identified](#) epigenetic lung changes that may help explain how cigarette smoke directly causes mutations known to cause lung cancer.

Research

- A *Nicotine and Tobacco Research* [investigation](#) of 12 tobacco product websites concluded that attributes like age verification techniques, interactive content, and content themes differed based on the type of tobacco product being promoted.
- A [cross-sectional study](#) of 25 addiction treatment facilities published in *Drug and Alcohol Dependence* concluded that facilities with tobacco-free policies in place were associated with less client and staff smoking, as well as increased delivery of

Truth Initiative is launching its new Tobacco-Free College Program, which offers 17-month grants of up to \$20,000 to community colleges and minority-serving institutions to adopt a 100 percent tobacco-free college policy. Grantees receive guidance through webinars, learning communities, and one-on-one consultations throughout the grant period.
