control interventions for low-income and rural populations.

- **FDA** extended the [public comment](#) period on Philip Morris' modified risk application for its IQOS heated tobacco products beyond the original Nov. 24 deadline, and announced that it will publish an additional notice 30 days prior to the revised deadline.
- A **CDC** [analysis](#) of National Adult Tobacco Survey data published in *Morbidity and Mortality Weekly Report* found that 20.1 percent of all adults use a tobacco product, including 17.6 percent that smoke any combustible tobacco product and 15.1 percent that smoke cigarettes.
- **American Lung Association** published a new [online toolkit](#) to help state and local public health professionals to help make the case for tobacco control in hospital community health needs assessments.

State News

- **Wisconsin** launched its "Tobacco is Changing" [multimedia campaign](#) to increase parents' awareness of flavored and electronic tobacco products that may appeal to children.
- A new [state quitline website](#) is now available in **Colorado**, featuring web-based cessation support and four weeks of free nicotine replacement therapy.

The American Cancer Society Center for Tobacco Control launched a third request for proposals for the TFGCI grant program to provide grants to accelerate and expand the adoption and implementation of 100 percent smoke- and tobacco-free policies on college and university

In the News

- On Nov. 26, tobacco companies began running court-ordered television and newspaper [corrective statements](#) to prevent future fraud and misconduct after being found guilty of racketeering. National tobacco control organizations issued a [press release](#) providing additional background and encouraging continued public health action to combat the actions of tobacco manufacturers.

Research

- A laboratory [experiment](#) published in *PLOS One* found that e-cigarette exposure might be correlated with craniofacial defects in developing mammal embryos.
- An [analysis](#) of nationally representative web survey data published in the *American Journal of Preventive Medicine* found that 73.7 percent of all Americans are in favor of smoke-free public housing, including 44.3 percent of current smokers and 73.2 percent of former smokers.
- A laboratory [experiment](#) published in the *Journal of Psychopharmacology* concluded that menthol heightened rats' sensitivity to nicotine when administered together.
