- ASTHO recently released the [ASTHO Profile of State and Territorial Public Health, Vol. 4](#), which details the results of the 2016 ASTHO Profile Survey. The report, which includes a general overview of agency activities, structure, and resources, found that 84 percent of state health agencies performed tobacco prevention services and 88 percent of state health agencies provided training to local health department personnel on tobacco control. - The Smoke Free Movies initiative of the **University of California, San Francisco** has a new [visual advertisement](#) available for free educational use.

State News

- The Alliance for a Healthier **Indiana**—a group composed of hospitals, business, and other stakeholders—is [supporting](#) a state bill that will repeal a prohibition of employers from screening job candidates for tobacco use.
- State Sen. Howie Morales (NM) [proposed](#) a bill to increase **New Mexico's** state cigarette tax by \$1.50 and establish equivalent taxes on other tobacco products to increase revenue for public schools.
- As a result of a press conference convened by the student group Dover Youth to Youth, state Sen. David Watters (NH) is [co-sponsoring](#) legislation to increase the tobacco product purchase age in **New Hampshire** to 21.
- The U.S. Supreme Court [declined](#) to hear an appeal of a lower court ruling that awarded \$825,000 to the family of a **Florida** woman who died of smoking-related illness.

- A [study](#) of nearly 332,000 Swedish construction workers [published](#) in *The Spine Journal* found that heavy smokers were 46 percent more likely than nonsmokers to have spinal surgery over a period of approximately three decades.
- British American Tobacco [announced](#) that recent changes to the U.S. tax code would result in a six percent increase in share earnings, which the company plans to invest in electronic smoking devices.

Research

- CDC published two *MMWR* articles on tobacco use prevalence. The first details the use of tobacco use among [veterans](#), finding that 29.2 percent of veterans currently use a tobacco product. The second report found that as of 2016, 15.5 percent of all U.S. [adults](#) reported being current cigarette smokers, with sociodemographic disparities in smoking prevalence persisting.
- A *Nicotine & Tobacco Research* [modeling](#) of employment data and smoke-free air policies from 1990 to 2015 found that there was a small but statistically significant positive association between the population covered by smoke-free bar and restaurant policies and bar and restaurant employment.
- An [analysis](#) of globally sourced data from 77 countries published in *Tobacco Control* concluded that implementing a point of sale cigarette advertising ban

nationwide is associated with a seven percent reduction in a country's adult smoking rate.

- A [phone survey](#) of 4,337 adults published in the *International Journal of Environmental Research and Public Health* found that a majority of Americans support nationwide policies to reduce nicotine in cigarettes and ban candy and fruit flavors in e-cigarettes and little cigars or cigarillos, while a majority of Americans do not support a menthol ban in cigarettes.
