A Message from the TCN Executive Committee

In January and February 2020, the Tobacco Control Network Executive Committee's Member Survey Workgroup, in collaboration with the CDC Office on Smoking and Health, conducted a TCN Member Survey of state and territorial health agency tobacco control program managers and Funders Alliance organization leads. The purpose of this effort is to evaluate the effectiveness of resources and services provided by TCN to its membership, and to identify opportunities for TCN to better support the needs of its members. A total of 22 program managers and Funders Alliance leads took the survey, and the Executive Committee is committed to ensure that the work of the TCN changes as a result of the input provided by members across the nation through survey results.

For the duration of the Executive Committee's implementation of the <u>2019-2022 TCN Strategic Map</u>, the Executive Committee will make the following changes to its work to better serve its membership:

TCN Resources and Regional Meetings

- Improve communications via email and on the TCN website to keep members better informed of all available TCN services and resources
- No longer produce podcast series uploaded to YouTube, and continue to explore effective and innovative ways to facilitate virtual learning
- Curate and disseminate a resource packet to help onboard new state health officials to the fundamentals of state and territorial tobacco control
- Continue to convene regular regional meetings, and increase emphasis on the sharing and discussion of region-specific challenges, emerging issues, and updates

2021 TCN Policy Recommendations Guide

- Include a systematic policy tracking element in the 2021 Policy Recommendations Guide by continuing to update and expand the <u>TCN Interactive State Tobacco Policy Map</u>
- Address youth e-cigarette use, tobacco industry tactics, preemption, and heated tobacco products in the forthcoming Policy Recommendations Guide

CDC Office on Smoking and Health Program Services Branch Support

 Work with OSH/PSB to recommend streamlining and refocusing of technical assistance and communications delivered to state and territorial tobacco control program grantees

- There is incredible information overload less content and more focus on the progress and capacity for progress of each state, as well as a single clearing house to go to for resources would be helpful.
- Cannot add anything at this time.



4) What education and capacity building needs do state health commissioners and other public health agency leaders have that TCN could address through future resources?

Responses (n=9):

- We STILL need state health AND state Medicaid commissioners to come together to support cessation services. Initiatives such as 6/18 are useless without buy in and direction to implement from the commissioners.
- Resources provided are thorough.
- How to collaborate better?
- Same as above. We have recently had a good bit of turnover in this position, and having a "go-to" document would be really helpful!
- Our state struggles with frequently changing leadership. It would be great to have (or if this
 already exists, for me to find) a one pager with talking points about the importance of
 comprehensive tobacco control and the role of a state tobacco control program.
- Our Health Officer is well versed in tobacco prevention.
- Education/capacity building opportunities should be targeted by level of progress of each state and/or regionally.
- The collaboration between ASTHO and TCN on the development and synthesis of resources is helpful.
- State comparisons to provide new information.
