State Success Stories

Minnesota's 2013 Tobacco Tax Increase is Improving Health (MN) – *MinnPost*. A year and a half after Minnesota implemented a 2013 tobacco tax increase the state is seeing real health benefits. Fewer Minnesota youth and adults are smoking, more smokers are quitting and while tobacco sales have decreased, tax revenue has gone up. Territories, and the District of Columbia. ASTHO members, the chief health officials of these jurisdictions, are dedicated to formulating and influencing sound public health policy and to ensuring excellence in state-based public health practice.



In the News

You're Out, Tobacco: Bill Would Ban Products at All California

Baseball Venues (CA) – California lawmakers have proposed a bill that would prohibit tobacco use in all baseball venues in the state, adding to legislation that has already banned tobacco in Californian minor league parks. State legislators and public health advocates believe the bill will discourage tobacco use by youth and hope it will send a message to other states, organized baseball and the players. Research

<u>Risk Factors for Exclusive E-Cigarette Use and Dual E-Cigarette</u> <u>Use and Tobacco Use in Adolescents</u> – *Pediatrics*. An analysis of risk factors associated with e-cigarette use and dual e-cigarette and tobacco use found that e-cigarette-only users were higher on risk status (elevated on risk factors and lower on protective factors) than nonusers but lower than dual users or cigarette-only users. Ecigarette-only and dual users often perceived e-cigarettes as healthier than cigarettes compared with nonusers.

<u>Waterpipe Tobacco Smoking: A Global Epidemic</u> – *Tobacco Control*. The journal *Tobacco Control* has published a supplement on the topic of waterpipe tobacco use that includes seven peerreviewed articles, an editorial introduction, and a postscript.

<u>Technology-Based Tobacco Interventions for Tobacco and Other</u> <u>Drug Use in University and College Students: A Systematic Review</u> <u>and Meta-Analysis</u> – *Addiction Science & Clinical Practice*. Evidence from a meta-analysis of 20 technological interventions targeting drug use in college students found that interventions targeting tobacco use led to overall increases in abstinence from tobacco.

<u>Electronic Cigarette Sales to Minors via the Internet</u> – *JAMA Pediatrics*. A cross-sectional study was used to estimate the extent minors can successfully purchase e-cigarettes online. The findings suggest minors are easily able to purchase e-cigarettes due to an absence of age-verification measures.
