<u>Public Health Law Conference</u> <u>2018</u> – The Network for Public Wisconsin has been having some pretty interesting conversations about the extent to which they as a program delineate between tobacco and commercial tobacco in their communications. They feel it's important to make the distinction, and like the strong message doing so sends to their movement, but they do have some practical questions that we're curious to see if other states have already dealt with or answered:

- 1. How have other states approached differentiating between tobacco and commercial tobacco?
- 2. For those that have focused on it, did they use certain terminology in all of their communications pieces or only in select pieces?
- Have any programs considered incorporating commercial tobacco into their names? They've thrown around the idea of putting it in front of their program name (e.g., "Wisconsin Commercial Tobacco Prevention and Control Program").
- 4. How have states approached using the terminology in media outreach? Do they stick with just saying "tobacco" or do they stay consistent and say "commercial tobacco"? If the latter, do they include a definition in their media pieces so people can understand the difference?
- 5. For programs that have implemented changes, what activities did they do to educate their leadership on the change (in order to maintain consistency)?

## **Job Listings**

- There have been several new announcements from the FDA Center for Tobacco Products:
  - FDA <u>issued</u> warning letters and fines to over 1,300 retailers for violations on selling e-cigarette products to youth and requested that the five largest e-cigarette manufacturers submit their plans to reduce youth consumption.
  - FDA <u>launched</u> their latest iteration of "The Real Cost" campaign, which aims to educate youth aged 12-17 on the risks of e-cigarette use through digital advertisements and school posters.
  - FDA opened a public comment opportunity for the U.S. Smokeless Tobacco Company's modified risk tobacco product application for its Copenhagen Sniff Fine Cut product.
  - FDA is <u>seeking</u> nominations for voting members of the Tobacco Products
     Scientific Advisory Committee through Nov. 13.
- According to CDC research published in the American Journal of Preventive Medicine, national call volume to the Spanish language tobacco quitline 1-855-DEJELO-YA more than doubled when Spanish "Tips from Former Smokers" advertisements appeared on television in 2013 and 2014.

## In the News

- An FDA scientific advisory committee approved many elements of RJ Reynolds Tobacco Co.'s modified risk application for its series of Camel Snus products. FDA has the authority to deny or approve the application, which would let those products be marketed as less harmful than cigarettes.
- An experiment involving middle and high school students published in *Nicotine & Tobacco Research* concluded that tobacco product displays and advertisements in a convenience store made students more likely to purchase e-cigarettes.
- Cigarette butts <u>remain</u> the most littered object in the world, driving environmentalists and other stakeholders to consider solutions.

### Research

An analysis of survey data published in JAMA
 Pediatrics found that 8.9 percent of middle and high school students reported ever consuming cannabis in an e-cigarette device, a figure that increases to 30.6 percent among students who reported ever using e-cigarettes.

ASTHO members, the chief health officials of these jurisdictions, are dedicated to formulating and influencing sound public health policy and to ensuring excellence in state-based public health practice.



- A Tobacco Control academic review of study reports submitted by Philip Morris International (PMI) to FDA for their iQOS modified risk application found discrepancies in PMI's claims to FDA and the underlying evidence, concluding that consumers are unlikely to understand the marketing claims made with regards to the relative risk of iQOS.
- A JAMA clinical trial of cigarette smokers found that smokers who immediately switched to using very low nicotine cigarettes experienced significantly lower exposures to harmful chemicals in cigarettes, a phenomenon not observed in the group that switched gradually to low nicotine cigarettes.
- An analysis of consumer product injury reports data published in *Tobacco Control* estimated that from 2015-2017, there were approximately 2,035 ecigarette explosion and burn injuries in the United States that resulted in emergency room visits.
